

## **POLICY REGARDING PRIVACY AND COOKIES**

The present Policy Regarding Privacy and Cookies regulates the handling of data of a personal nature which occurs as a consequence of accessing and using the web page [www.buensam.org](http://www.buensam.org) [www.buensam.es](http://www.buensam.es) (hereafter referred to as the “web”), owned by the Good Samaritan Association (ASOCIACION EL BUEN SAMARITANO), CIF number G14368922 and with the street address AVENIDA DEL SILO 14 BAJO, 14400, POZOBLANCO (CORDOBA). In addition, this policy statement also informs the user regarding cookies used on our web.

### **Privacy Policy**

Use of the web by a person means that said person has the status of a “user” (hereafter, “the User”), and implies knowledge and acceptance of all the conditions included in this Policy Regarding Privacy and Cookies. The User should read said Policy carefully each time the web is used, since it may be changed at any time.

### **Gathering, Handling and Use of Personal Data on the Web**

On the basis of the General Regulation Regarding Protection of Data 2016/679 and on the basis of Organic Law 3/2018 of the 5<sup>th</sup> of December regarding Protection of Personal Data and Guarantee of Digital Rights, we inform you that for you to make use of some of the services that our web offers, it may be necessary that you supply us with certain data of a personal nature that will be incorporated into automated files.

In compliance with the new provisions of European Union Regulation 2016/679 of the European Parliament, and of the Council of April 27<sup>th</sup>, whose norms came into effect as of May 2018, regarding the protection of physical persons with respect to the handling of personal data and with respect to the free circulation of this data and by which the previous law, Directive 95/46/CE (General Regulation Regarding the Protection of Data) is repealed, we inform you that **the entity responsible for handling the data** is the Good Samaritan Association.

Being of a general nature, the data gathered will be managed with the goal of providing the services offered through the web or handling other types of relationships with the Good Samaritan Association that may be formed as a consequence of requests, actions or procedures that the User may make or request through the web. The data handled by us will be those provided to us via the various forms which the web page may contain at any given time, or through the e-mails which the User may send to the e-mail addresses identified on the web, as well as other e-mails that may be generated during the maintenance of the corresponding relationship.

All the fields that appear marked as required on any of the forms must necessarily be filled in. Omitting the needed information on any of them can mean that it will be impossible for us to attend to the request or provide the corresponding services.

Additionally, during that gathering of data, it is possible that the User's consent may be requested for another series of purposes that do not have a direct relation to the service or to the corresponding relationship. If you are not in agreement with that additional process, simply check or uncheck accordingly the little box that is there for that purpose.

### **Sharing or Surrender of Data to Other Entities**

The data gathered on the web pages can only be shared with other entities for the development, maintenance and control of the legal relationship that may be established or when legal authorization exists to do so. The User's permission so that the data might be shared or surrendered as established above, may always be revoked, without such revocation having a retroactive nature.

Except for the above provisions in the previous paragraph, the Good Samaritan Association will not share the personal data of the Users with any third party, **unless it first obtains the prior consent of the User(s) to do so, in the manner legally required.**

### **Accuracy, Updating and Retention of the Personal Data of the Users**

When sending us personal data through the aforementioned forms on the web or via e-mails to the corresponding e-mail addresses, the User declares that the information and data provided are accurate and true, and that he or she is 18 years of age or older. The services of the web are not directed to those younger than 18 years of age, so we do not in any case have provision for parental consent. It will be the responsibility of the User to keep his or her personal data continually updated and correct.

The Good Samaritan Association will retain the personal data for as long as it may be necessary to provide the services or attend to the needs of the Users, and in any case, for the periods legally foreseen for each case.

### **Exercising Rights of Access, Correction, Cancellation and Objection**

The Users may object to the processing of any of their data that are not strictly necessary for the providing of services offered on the web and to its use for any purpose other than the maintenance of their relationship as specified on the web.

The Users are hereby duly informed and therefore may exercise, **at any moment**, their rights of access, correction, cancellation or objection to the handling of their data, as well as revoking their consent or exercising their right to the expunging of their data according to the terms legally foreseen, using the following e-mail address: [buensam@buensam.org](mailto:buensam@buensam.org) or the street address of the Association, enclosing a copy of the document that accredits their identity.

## **Commercial Communications**

In the cases in which the User shall have given consent to receive commercial communications, the Good Samaritan Association will be able to send said User commercial or advertising information by whatever means, including electronic media (e-mail, text messages, etc.), be it of a general nature or adapted to the User's personal characteristics, regarding its products or services, including participation in drawings (raffles), events and satisfaction surveys.

In any case, the User may object to the sending of the commercial communications at any time, via the sending of a message to the street address or electronic address given above, or using the specific means included in the same commercial communications that are sent.

## **Links to Other Sites**

The web may contain links to other sites not associated with the Good Samaritan Association, meaning that we can neither guarantee nor be responsible for the handling of personal data that the user may provide on those third-party websites. In consequence, we recommend that the User review the privacy policies on said sites.

## **Policy Regarding Cookies**

The Good Samaritan Association, in compliance with Law 34/2002, of July 11<sup>th</sup>, regarding services of internet providers of information and electronic commerce (LSSI), and the consolidated text dated May 10<sup>th</sup>, 2014 (Article 2 in relation to the definition of Annex a, 22.2, 37, 38.4g, 38.3i), informs its Users regarding its Policy Regarding Cookies on its website through the following paragraphs.

## **What are Cookies?**

A cookie is a file that is downloaded and stored on the equipment of the User when accessing certain websites, in order to store and recover information about the navigation that is done using said equipment. Cookies are essential for the functioning of the internet, affording advantages for the provision of interactive services, making navigation and use of the website easier. Keep in mind that cookies cannot damage your equipment and that on the other hand, their being activated helps us identify and resolve errors.

## **Blocking or Disabling of Cookies**

The User may permit, block or eliminate the recording of the data provided by the cookies installed on their equipment by configuring the options in the internet browser installed on their computer. Some information is available through the following link:
